### I. COURSE DESCRIPTION

This course will give students an introductory understanding of the sufficiency of Scripture to help people with their mental, emotional, spiritual, and relational problems. Students will observe the Word of God as profitable to tend to mankind's needs in distinction from secular sciences. Students will observe biblical perspectives on the human condition and be introduced to basic, biblical principles to address man's issues.

### III. MEASUREABLE LEARNING OUTCOMES

• The student will demonstrate an understanding of God's original plan for mankind as well as the source and solution of man's sin problem.

- The student will demonstrate and discuss how the effects of sin affect mankind mentally, emotionally, and spiritually.
- The student will demonstrate an understanding of basic principles forming the foundation of helping others deal with life's problems while understanding his or her own limitations.
- The student will demonstrate an understanding of how applying scripture to the human condition is more sufficient than secular methodologies.
- The student will demonstrate an understanding of how man's thought patterns affect his attitudes and actions and be able to explain how biblical truth can be applied to change thought patterns.
- The student will demonstrate an ability to practically and biblically address common issues that take place in the process of ministering in the context of the local church.

# IV. REQUIRED ASSIGNMENTS

- There will be weekly post-lecture quizzes. (20% of grade)
- The student will compile an accurate and complete notebook of all lecture material given in class.
- The student will write a 5-page analysis of A Path Well Lit: A Theology of Biblical Counseling by Brandon Briscoe & Jonathan Kindler. (30% of grade – due May 4<sup>th</sup> @ 11:59 pm CST)

- Each student will participate in four different counseling scenarios. (20% of grade)
  - You will have access to the scenarios on the Saturday of the week they are assigned, and they will be due the next Monday.

# X. ATTENDANCE POLICY

- Living Faith Bible Institute requires 100% attendance. All attendance issues will be handled directly by the course instructor within your specific class. From there, it may be deferred to the Registrar's Office. If a student misses' class but believes it may be excused, they will contact the Registrar. We believe that students have many potential extenuating circumstances that contribute to absence and for this reason, course records distinguish between excused and unexcused absence. The Registrar's Office staff is available to help students regarding any concern with attendance.
- Whether you are attending classes online or in person, it is important for students to put together a personal attendance plan. Being present and prepared for class is critical to getting the instructional experience necessary for growth. The following are the attendance requirements and policies for LFBI:

- Students are responsible for all missed information, instruction and assignments accrued while absent from class.
- For online students, if you miss the live viewing of any class lecture, you will have **ten days** to view the class online before the corresponding quiz becomes inaccessible and you are considered absent.
- All students who miss class (i.e., sickness, missions' trips, work schedules) will be expected to stay caught up with each week's class. Instructors may, at their discretion, grant extensions to students who miss class under special circumstances.
- Students who wish to contest an unexcused absence may fill out the Absence Form on the Resource page of myLFBI for review by the Registrar's Office.
- When in live attendance, the student is expected to show common courtesy to the professor and fellow students by being punctual. Students who are regularly late to class or are a distraction to other students are susceptible to being reported to the Registrar's Office.

# XI. DROP POLICY

- Students have until the second week of semester classes to enroll for credit. The penalty for late enrollment is missing the quizzes for the sessions while they were not enrolled.
- There will be no refunds for early withdrawal beyond the second week of class or for incomplete classes.
- Students who enroll in Fall or Spring courses may be re-assigned as an "audit student" upon request prior to the end of week 4 but will not receive a refund. After week 4, all students will receive their earned grade.
- Students who enroll in Summer Self-Pace courses may be reassigned as an "audit student" upon request prior to the end of week 3 but will not receive a refund. After week 3, all students will receive their earned grade regardless of what was completed.
- Students will receive a failing grade for an incomplete course. The failing grade will go on their transcript. Contact the registrar to change enrollment status prior to the designated time.
